TO HAVE AND TO HOLD unto and for the use of the lessee for the term of five years from the date hereof and as much longer as oil and gas is produced in paying quantities, yielding to the lessor these one-eighth part of all oil produced and saved from the premises delivered free of expense into tanks or pipe lines to the lessor's credit.

Should a well be found producing gas only, then the lessor shall be paid for each suchg gas well at the rate of One Hundred Bifty Dollars for each year, so long as the gas is sold therefrom, payable quarterly while so marketed.

Lessee agrees to complete a well on said promises within Twelve months from the date hereof, or pay the lessor thereafter the sum of One Dollar per acre per annum in advance untitle said well is completed or this lease surrendered. And the firilling of such well productive or otherwise shall be full consideration to lessor for this grant hereby made to lessee with exclusive right to drill one or more additional wells on the premises during the term of this lease.

Lessor is to fully use and enjoy said premises for the purpose of tillage, except such parts as may be used by lesses for the purposes a foresaid. Lesses is not to put down any well on the lands hereby leased within ten rods of the buildings now on the said premises without the consent of the lessor in writing, Lessor may, if any well or wells on saidpremises produce sufficient gas, have gas for domestic purposes for one family, the lessor paying for comnections at such points as may be from time to time designated by lesses.

The above rental shall be paid to lessor inperson or by check deposited in postoffice directed to...... And it is further agreed, that lessee shall have the right to surrender this lesse upon payment of One and no/100 Dollars and all amounts due hereunder and Thessalts shall be released and discharged from all payments, obligations, covenants and conditions herein contained, whereupon this lesse shall be null and void, and that all conditions, terms and limitations between the parties hereto shall extend to the heirs, successors, personal representatives and assigns.

Lessor agrees that recordation of a surrender in the proper county and a deposit of all amounts then due hereunder to lessor's credit in First Nat. Bank, Tulsa, Okla., shall be and be accepted as full and legal surrender of lessor's rights under this lease.
