

And it further appearing that it is for the best interest of said minor to have said above described land developed for oil and gas purposes, in order that funds may be obtained for the proper education, maintenance and support of said minor. And it further appearing that the estate of the said minor is not financially able to develop said land for oil and gas purposes. And it further appearing that under an order of this Court heretofore made and issued, Willis Jones, Guardian, has executed to J. Blair Shoenfelt, an oil and gas mining lease on the above described land of said Isaac Jones, a minor; and it further appearing that said J. Blair Shoenfelt has paid therefor the sum of Forty & no/100 Dollars (\$40.00); and it also <sup>further</sup> appearing that said sum is a good and sufficient bonus for said oil and gas mining lease, and is as much as could be obtained therefor; and it further appearing that said J. Blair Shoenfelt is financially able to develop said oil and gas mining lease; and it further appearing that Willis Jones and Isaac Jones are both residents of Muskogee County, State of Oklahoma.

NOW, THEREFORE, It is ordered, adjudged and decreed that the said oil and gas mining lease executed as aforesaid by said Willis Jones, as guardian of <sup>said</sup> Isaac Jones, a minor, to J. Blair Shoenfelt, and covering the land above described of said Isaac Jones, be, and the same is hereby in all respects ratified, confirmed and approved.
