OIL AND GAS LEASE.

AGREEMENT, Made and entered into the seventeenth day of August A. D., 1908, by and between Fred Geier, C. H. Hahnemann, Henry Muthh, J. M. Wilson and F. W. Geier, all of Pittsburg, Crawford County, Kansas, except ~~Fred Geier~~ ^{Edward} ~~above named~~ who is of ~~Crawford~~ ^{Edward}, Crawford County, Kansas, R.F.D. No. 5, parties of the first part, and Eastern Oil Company, of Buffalo, New York, party of the second part.

WITNESSETH, That the said parties of the first part for and in consideration of the sum of One Dollar, to them in hand well and truly paid by the said party of the second part, the receipt of which is hereby acknowledged, and of the covenants and agreements hereinafter contained on the part of the said party of the second part, to be paid, kept and performed, has granted and conveyed, and by these presents does grant and convey unto the said party of the second part, ^{to successors or assigns} for the sole and only purpose of mining and operating for oil and gas, and of laying pipe lines; and of building tanks, stations and structures thereon to take care of said products, all that certain tract of land situate inTownship, Tulsa County, Oklahoma to-wit:
