Nancy Barnett, of lawful age, being by me, first duly sworn says; that she is a resident of the State of Oklahoma and a citizen of the Creek Indian Tribe, that she is the widowed wife of Louis Loler, deceased; that said Louis Loler was a full-blood Creek Indian, and that he died some time during the month of January 1901, at or near the City of Tulsa, Oklahoma, that Louis Loler had no children either living or dead at the time of his death, and that at the time of his death he was the owner by allotment of the South One Half (S $\frac{1}{2}$) of the South west Quarter (SW $\frac{1}{4}$) of Section Fifteen (15), Township Eighteen (18) North, Range Thirteen (13) East, in what is now Tulsa County, Oklahoma; that this affiant and Louis Loler deceased were legally married and lived together as husband and wife up until the time of the death of said Louis Loler; that this affiant has never conveyed her interest in or to the land owned by said Louis Loler at the time of his death to any person for a valuable consideration except the conveyance made this day to Nate Skidmore, and that said land so conveyed has never been used or occupied by this affiant as a homestead, nor is it now occupied by this affiant in any capacity whatever.
