the term of said lease be extended to as long as oil or gas is found in paying quantities and that said lease when executed shall have all the privileges, conditions and terms of the lease form approved and issued April 20, 1908, by the Secretary of the Interior, and that the stipulation subjecting said lease to the regulations of June 11, 1907, as amended October 14, 1907, be revoked and cancelled:

And it has been shown to the Secretary of the Interior, that the owner of said lease has notified the owner of the land described in satellease of his willingness to increase said royalty on oil on the terms and conditions herein stated.
