STIPULATION INCREASING OIL ROYALTY, EXTENDING TERM OF LEASE, AND CONCELING REGULATION OF OCTOBER 14; 1907.

(TO BE EXECUTED IN QUADRUPLICATE.)

WHEREAS, the Secretary of the Interior has heretofore approved an oil and gas mining lease (no. 13333), dated May 9, 1907, entered into by and between Moses Jefferson, lessor and Robt. Jordan, lessee, and wherein the oil royalty is stipulated to be ten er cent of the gross proceeds; and,

WHEREAS, the undersigned, the present owner of said lease is willing to increase the royalt on oil in said lease to twelve and one half per cent of the gross proceeds, on condition that the term of said lease shall be extended to as long as oiland gas is sound in paying quantities and that said lease when extended shall have all the rights, privileges, conditions and terms of the lease form approved and issued April 20, 1908, by the Secretary of the Interior, and that the Stipulation subjecting said lease to regulations of June 11, 1907, as mmended October 14, 1907, be revoked and cancelled:

And it has been shown to the Secretary of the Interior that the owner of said lease ha--notified the owner of the land described in said lease of his willingness to increase said royalty on oil on the terms and conditions herein stated:

NOW, THEREFORE, the owner of said lease on the terms and conditions herein stated do --hereby agree that from and after the date hereof, the royalty on oil in said lease shall be twelve and one half per cent of the gross proceeds from the real estate herein described, and in consideration thereof the term of said lease shall be and the same is hereby extended to as long as oil and gas is found in paying quantities, and that all the rights, privileges, conditions and terms of the lease form approved and issued April 20, 1908, by the Secretary of the Interior, and of this contract, are made a part of said lease first above described, the same as if written therein at length, and all the terms and conditions of said lease as originally executed in conflict with the terms and conditions hereof and of said lease form approved April 20, 1908, are rescinded and cancelled. The stipulation subjecting said lease to the regulations of June 11, 1907, as amended October 14, 1907, and to Department. letter of Secptember 26, 1907, is hereby revoked and rescinded.
