STIPULATION INCREASING OIL ROYALTY, EXTENDING TERM OF LEASE, AND

CANCELING REGULATION OF OCTOBER, 14, 1907.

(TO BE EXECUTED IN QUADRUPLICATE)

WHEREAS, the Secretary of the Interior has heretofore approved an oil and gas mining lease (No. 13164), Dated May 8, 1907, entered into by and between Joe Childers, lessor, and Robt. Jordan, lessee, and wherein the oil royalty is stipulated to be ten per cent of the gross proceeds; and

WHEREAS, the undersigned, the present owner of said lease is willing to increase the royalty on oil in said lease to twelve and one half per cent of the gross proceeds, on condition that the term of said lease shall be extended to as long as oil or gas is ^{found} produced in paying quantities, and that said lease when extended shall have all the rights, privileges, conditions and terms of the lease ^{that} form approved and issued April 20, 1908, by the Secretary of the Interior, and the stipulation subjecting said lease to the regulations of June 11, 1907, as amended October, 14, 1907, be revoked and cancelled:

and it has been shown to the Secretary of the Interior that the owner of said lease has notified the owner of the land described in said lease of his willingness to increase said royalty on oil on the terms and conditions herein stated.

NOW, THEREFORE, the owner of said lease on the terms and conditions herein stated do hereby agree that from and after the date hereof, the royalty on oil on said lease shall be
