

twelve and one half per cent of the gross proceeds from the real estate therein described, and in consideration thereof the term of said lease shall be and the same is hereby extended to as long as oil or gas is found in paying quantities, and that all the rights, privileges, conditions and terms of the lease form approved and issued April 20, 1908, by the Secretary of the Interior, and of this contract, are made a part of said lease first above described, the same as if written therein at length, and all the terms and conditions of said lease as originally executed in conflict with the terms and conditions hereof and of said lease form approved April 20, 1908, are rescinded and cancelled. The stipulation subjecting said lease to the regulations of June 11, 1907, as amended October 14, 1907, and to Department letter of September 26, 1907, is hereby revoked and rescinded.
