

AND WHEREAS, it was the intention of the parties to said lease dated the 25th, day of February as aforesaid, to give the lessees, Daley and Shrewsbury, 90 full days in which to commence said well mentioned above.

Now in order to more fully carry the intention of the parties of said lease, dated the 25th, day of February, from said Soney Smith/ Guardian, to said Daley and Shrewsbury, and in further consideration of the sum of \$1.00 to first party in hand paid by second parties, receipt of which is hereby acknowledged and in consideration of the promises and agreements of second parties hereunder, first party, the said Soney Smith, Guardian of said Minor, hereby agrees with second parties, the said Daley and Shrewsbury, that the time in which said well is to be commenced on the said property last above described under the provisions of said lease, dated the 25th, day of February 1909, shall be and the same is hereby extended and that the said 90 day period shall commence to run from and after written notice has been received from the Department of the Interior by the said Soney Smith, of the cancellation by the Department of the Interior of said leases to the said Penn Oil Company, or the receipt by said Soney Smith of said leases to the Penn Oil Company, Properly cancelled by the Department of the Interior, and the said Soney Smith has in turn notified said R. H. Shrewsbury and W. F. Daley of such cancellation.

Said contract and lease, dated February 25th, 1909 between the parties hereto, is hereto attached, marked "Exhibit A" and hereby made a part hereof, and it is agreed that the same as amended by this agreement shall remain in full force and effect.
