## DEED OF GURADIAN.

THIS INDENTURE, Made this 3rd, day of April, 1909, by and between menry Byrd, the duly appointed, qualified and acting Guardian of Susie Byrd, a minor, party of the first part, and Chas. L. Brown and Hiram E. Ellingwood, parties of the second part:

WITNESSETH: That Whereas, on the first day of March, 1909, the County Cou rt within and of for the County of Cherokee, State of Oklahoma, made an order of sale authorizing the said party of the first part to sell certain real estate of said Susie Byrd, a minor, said land being situated in the Cou nty of Tulsa, State of Oklahoma, and specified and particularly described in said order of sale, either in one parcel or in separate parcels, as said party of the first part shold judge most beneficial to said estate, and which said order now on file and of record in said County Court hereby referred to and made a part of these indenture;

Brown and Hiram E. Ellingwood were declared to be the highest and best bidders for the tract of land to be sold their bids for the entire tracts being Six Hundred Fifty (\$650.00) Bollars, which was the full amount of the appraised value of the land and that being the highest and best bid for the said tract of land, the same was accordingly sold to said Chas L. NOW, THEREFORE, the said Henry Byrd, Guardian of the estate of Susie Byrd, a minor, part of the first part, pursuant to the order of the County Court last above mentioned, and for and in consideration of the sum of Six Hundred Firsty (\$650.00) Dollars to him in hand paid by the parties of the second part, the receipt of which is hereby acknowledged, has granted, bargain ined, sold and conveyed, and by these presents does grant, bargain, sell and convey unto the said parties of the second part, their heirs and assigns forever, all the right, title, interest and estate of the said Susie Byrd, a minor, in and to the following described as follows, situated in the County of Tulsa, State of Oklahoma, and more accurately described as follows, to-wit:
