RIGHT OF WAY GRANT.

KNOW ALL PEN BY THESE PRESENTS:

That the undersigned, W. R. McKee (hereinafter styled "Grantor") in consideration of Thirty Dollars (\$50.00) Dollars in hand paid by the Texas Company, a corporation of Texas, doth hereby grant and convey unto the said The Texas Company (herein styled "Grantee") its successors and assigns, the right to construct, operate and maintain a pipe line for the transportation of oil or gas over, through and upon a certain tract of land situated in the County of Tulsa, State of Oklahoma and described as follows:

W. 2 of W. 2 of NW. 2 of Sec. 14, Twp. 19 North, Range 12 East.

There is also hereby granted the right to erect and manimitain upon and across said premises, a line of poles and telegraph and telegraph wires thereon, and also the right to lay adjacent to and parallel with the first ripe line a second pipe line, and the grantee, its successors and assigns, shall at all reasonable times have the right of ingress and egress to and from said line or lines for the purposes of construction, inspecting, repairing and maintaining the same and the removal of such at will in whole or in part.

The Grantee, its successors and assigns, to select the route of such lines. In the event of buildings being erected, and Pipe line is in the way of Foundations, same will be moved at expense of The Texas Co.

TO HAVE AND TO HOLD the saideasements unto the said The Texas Company, its successors and assigns, so long as such structues are maintained.

By acceptance hereof, the grantes covenants for itself, successors and assigns, that it will so bury said pipe lines as that such will not interfere withe the cultivation of the premises and also that it will pay for all damages to crops, fences and land, which may be suffered from the maintaining and operating of said pipe line.

It is understood that the person securing this right of way in behalf of the Grantee is without authority to make any covenant of agreement in respect to the premises not expressed herein.
