. RIGHT OF WAY GRANT.

STATE OF OKLAHONA, COUNTY OF TULSA.

KNOW ALL MEN BY THESE PRESENTS:

That the undersigned, Annie H. Hanlin (hereinafter stlyed "Grantor"), in consideration of Sixteen & no/100 Dollars in hand paid by The Texas Company, a corporation of Texas, doth hereby grant and convey unto the said The Texas Company, (herein styled "grantee") its successors and assigns, the right to construct, operate and maintain a fipe line for the transportation of oil or gas over, through and upon a certain tract of land situated in the County of Tulsa, State of Oklahoma and described as follows:

W.1 of SE.1 Sec 24, Twp. 21 North, Range 12 East.

There is also hereby granted the right to erect and maintain upon and across said premises, a line of poles and telegraph and telephone wires thereon, and also the right to lay adjacent to and parallel with the first pipe line a second pipe line, and the Grantee, its successors and assigns, shall at all reasonable times have the right of ingress and agress to and from said line or lines for the purpose of construction, inspecting, repairing and maintaining the same and the removal of such at will in whole or in part.

The Grantee, its successors ad assigns, to select the route of such lines.

TO HAVE AND TO HOLD said easements unto the said The Texas Company, its successors and assigns, so long as such structures are maintained, Telegraph line to be constructed on land lines.

By acceptance hereof, the grantee covenants for itself, successors and assigns, that it will so bury said pipe lines as that such will not interfere with the cultivation of the premises, and also that it will pay all damages to crops, fences and land, which may be suffered from the maintaining and operating of said pipe line.
