THIS INDENTURE OF LEASE made and entered intoin quadruplic ate, on this 3d, day of September, A. D. 1904, by and between Winfield Williams, Guardian of Annie G. Williams, of Dawson, I. T. party of the first part, and Alex S. Lewis and STEphen R. Lewis of Dawson, I. T. parties of the second part, under and in pursuance of the provisions of section 72 of the Act of Congress approved July 1, 1902, and ratified by a majority vote of the legal voters of the Cherokee Nation on August 7, 1902, and the rules and regulations prescribed by the Secretary of the Interior relative to mining leases in the Cherokee Nation:

WITNESSETH, that the party of the first part for and in consideration of the royalties, covenants, stipulations and ponditions hereinafter contained and hereby agreed to be paid, observed and performed by the parties of the second part, their heirs, executors, administrators or assigns, does hereby demise, grant and let unto the parties of the second part, their heirs executors, administrators or assigns the following described tract of laind lying and being within the Cherokee Nation and within the Indian Territory, tewit:

Then. W. 1 of N.W.1 of Section 27 of Township 20 N. of Range 13 East of the Indian Meridian and containing 40 acres, more or less, for the full term of eleven years and ten months from the date hereof, for the sole purpose of prospecting for and mining coal and asphalt
