In the event lessee desires this lease cancelled they shall obtain an order of the County Court to that effect, pay all accrued costs on account of said lease, ad pay all existing obligations by virtue of provisions in this lease contained. At any time from the date of the approval of this lease, if the conditions herein contained have not been complied with, the lessor may apply to the County Court of Rogers County, State of Oklahoma, and have said lease annualled, by delivering to the lessee, written notice or by mailing to the lessee, or his agent such a notice of his intention to have said lease annualled, which notice shall be delivered or deposited in the post office ten days prior to the time \$\$ his intention of making application to have said lease annualled.
