ARTICLES OF INCORPORATION: -

BE IT KNOWN, That the undersigned citizens of the State of Oklahoma, do hereby voluntarily associate ourselves together for the purpose of forming a provate corporation under the laws of the State of Oklahoma, and do hereby cetify:

FIRST:

That the name of this corporation shall be The Macedonia Baptist Church, of Tulsa, Oklahoma.

SECOND:

That the purposes for which this corporation is formed are to do missionary and educational work; to form a society of persons of the Missionary Baptist Church. The general purposes of this corporation is to promote morality and uprightness of life among its members generally and to spead the gospel of Jesus Christ? Its general plan of op eration is to preach the Gospel and convert sinners to belief in Christ and upon their confession and repertance to receive them as members, when favorably voted upon by the membership of this corporation.

Terms of admissionare, that the applicat shall profess faith in Jesus Christ and accept baptisim by immersion and these are the requisites for membership. Officers shall be selected by majority vote of members and vacancies filled in like manner. This corporation shall be goverened by the laws, usages and commentaries of the Baptist Church as set cut in "the New Directory of Baptist Churches", by Edward T. Hiscox.

THIRD:

That the place where its principal business is to be transacted is at Tulsa, Oklahoma. FOURTH:

That the term for which this corporation is to exist is perpetually.
