DECLARATION OF TRUST.

TO ALL PERSONS TO WHOM THESE PRESENTS SHALL COME, The First United Presbyteriam Church, of Tulsa, in the State of Oklahoma, a corporation of said State, sends greeting:

, WHEREAS, by deed bearing date the ----- day of February, A. D. 1909. and made between The Board of Church Extension of the United Presbyterian Church of North America, of the first part, and the said corporation, of the second part, the said party of the first part, for the consideration therein mentioned, did grant, bargain, sell and convey to the said corporation all that parcel or lot of land, situate in the City of Tulsa, in the County of Tulsa, and State of Oklahoma, bounded and described as follows, to-wit:
