

by the said General Assembly of said Church; and that in case the said The First United Presbyterian Church of Tulsa, shall cease to exist, be dissolved or cease to be connected with and subject to the jurisdiction of said General Assembly, or shall loose its corporate existence, the trust shall terminate, and the title shall vest absolutely in the Trustees of the general Assembly of the United Presbyterian Church of North America, who shall then have the right to sell and convert the same into money without any liability of the purchaser of the property to see to the application of the proceeds of such sale. And the said Trustees of the General Assembly of the United Presbyterian Church of North America may, at any time in their discretion, quit-claim said property to said The First United Presbyterian Church of Tulsa, so as to vest in it the indefeasible title thereto discharged of said trust, or may permit the said The First United Presbyterian Church of Tulsa to mortgage said property so that the rights of the mortgagee shall be superior to and free and discharged of the rights of said Trustee. And

WHEREAS, At a meeting of the members of said The First United Presbyterian Church of Tulsa on the ----day of March, A. D., 1909, the Trustees of said Corporation were duly authorized and directed to make, deliver and record, in he name of said corporation, and sealed with its common and corporate seal, a declaration of trust, covering the said real estate of said corporation hereinabove described, in conformity with the condition and requirements above recited: Provided that in case of any of the above recited defaults or the sale of the premises from any cause, the sum of Five Thousand & Three Hundred (\$5,300.) with interest from the date hereof shall be paid to the said Board of Church Extension of the United Presbyterian Church of North America, being purchase money paid by the said Board for the said lot, and the erection of a church thereon, and the above named sum shall be a first lien on the premises.

NOW, THEREFORE, such declaration of trust is hereby made; and is is hereby acknowledged and decared that the said land and premises are held in perpetual trust for the use and purpose hereinbefore stated, and subject to the condition and requirements above recited, and for no other use or purpose whatever.
