O R D E R.

Now on this 12th day of April 1909, this matter came on for hearing upon the petition of Polly Skeeter, as an heir at law of the said Nathaniel Brown, deceased, praying for an order of court approving a certain deed of conveyance, by her executed, unto Grant R. McCullough, conveying to the said ~~Grant R.~~ McCullough the lands below described, and the petitioner appearing in person and by her attorneys Abbott and Brown, and the court after hearing the testimony of the petitioner and the evidence of witnesses and being fully advised in the premises; finds,

That the allegations in the petition contained ~~are~~ true; that the said petitioner is a full blood Creek Indian, of lawful age, and is duly enrolled as such; that the said Nathaniel Brown deceased, was a one-eighth blood Creek Indian, duly enrolled as such and that there ^{was} ~~has been~~ allotted to him, as a portion of his distributive share of the lands of the Creek Nation, the following described lands, situate in what is now Tulsa County, Oklahoma, to-wit:

Beginning at a point on the North line of Northwest Quarter of the Northeast Quarter of Section Fifteen (15), in Township Nineteen (19) North of Range Twelve (12) East of the Indian Meridian, 528 feet East of the North ~~west~~ corner thereof, and running thence East on said North
