WHEREFORE, it is by the Court considered ordered and adjudged and decreed that the action of the said Mary Grayson in executing said lease affecting the interests of said minors in andto the lands described in said lease, be and the same is hereby approved, ratified and confirmed.

OIL AND GAS MINING LEASE.

THIS INDENTURE, Made the 6th, day of April, A. D., 1909, between Mary Grayson, for herself and Mary Grayson, as Guardian of Samuel Grayson, Priscilla Grayson, Julia grayson, and Katie Grayson, minors, and Louella Perryman (nee Grayson), Jennette Webb (nee Grayson) Walter Grayson and Pleasant Grayson, County of Tulsa, and State of Oklahoma, lessors, and Charles Page lessee.

WITNESSETH: That the lessors, in consideration of One Hundred Sixty (\$160.00) Dollars, the receipt whereof is hereby acknowledged, being bonus, does hereby grant, demise and let unto the said lessee, all the oil and gas in and under the following described tract of land, with covenant forthe lessee's quiet engoyment of the term, and that the lessor hat the right to convey the said premises to saidlessee, together with the exclusive right unto the lessee to operate and drill for petroleum and gas, to lay and maintain pipe lines, to erect and maintain telephone and telegraph lines, and buildings convenent for such operations; and the right to use water and gas from the said lands in operating same, and the right of way over same for any purpose and the right of ingress, egress and regress for such purposes, and of removing either during or at any time after the term hereof, any property or improvements placed or erected in or upon said land by said lessee, and the right of subdividing and releasing allor any part of that tract of land situated in the County if Tulsa and State of Oklahoma, and described as follows, towit:
