a reasonable attorney! s fee therefor, in addition to all legal costs andfees, and hereby agrees that \$50.00 is a reasonable attorneys fee, said fee to be due and payable upon the filing of petition for foreclosure, and the same shall be a further charge and lien upon, said premises described in this mortgage.

NINTH.
