TO HAVE AND TO HOLD THE SAME, together with all the appurtenances thereunto belonging or in anywise appertaining forever.

And the said party of the first part for himself, his heirs, executors or administrators does hereby covenant to and with said party of the second part, her heirs and assigns, against all and every person whomsoever, lawfully claiming the same.
