THIS AGREEMENT, Made and entered into at Tulsa, Oklahoma, own this the 22nd, day of April A. D., 1909, by and between W. F. Daley, of Tulsa, Oklahoma, party of the first part and A. T. Kreps, Jr. and R. H. Shrewsbury, both of Tulsa, Oklahoma, parties of the second part WITNESSETH AS FOLLOWS:

WHEREAS the said first party did on the 13th, day of April, A. D. 1909, bargain, sell and Grant unto second parties the exclusive option and tright, for a term commencing on said 13th, day of April, A. D., 1909, and expiring at mid-night on the 23rd, day of April A. D., 1909, to purchase from first party, in consideration of the further payment of \$8900.00 all first party's right, title and interest in and to and under certain leases for oil and gas mining purposes, which said leases were fully described in said option bearing date of April 13th, A. D., 1909 as aforesaid and which said option is hereby referred to and made a part hereof the same as if fully incorporated herein.

Now, in consideration of the sum of \$1.00 cash in hand paid to first party by second parties, receipt of which is hereby acknowledged by first party, said first party hereby extends the time within which said second parties shall have the right to purchase the right, title and interest of said first party in said leases as fully set out in said option of April 13th A. D., 1909, for a period of men (10) days from and after mid-night of April 23rd, A. D. 1909. That is to say, said period shall not expire at mid-night on the 23rd, day of April 1909, as in said original option provided but shall expire on the 3rd, day of May A. D. 1909 at mid-night.

Said option dated April 13th, A. D. 1909; as amended by this extension is hereby ratified and confirmed, and re-affirmed.

It is agreed that time is of the escence of this contract and that if second parties do not avail themselves of their rights hereunder within the time above specified, to-wit: On or before mid-night of the 3rd, day of may, A. D., 1909, then this contract shall become null and void and said first party shall retain all monies paid to him either under said original coption; or under this extension.

Said First Party hereby binds his heris, executors and administrators firmly by these presents.
