any tourt of competent jurisdiction or by sale of such property of such owner or owners in the manner provided in this charter for the sale of property for other taxes. Such assessment shall include all costs and expenses of collection of same, where such costs are incurred, including reasonable attorney's fees, where such attorney's fees a re incurred. In all cases where sale of property shall be made for any payment of any assessment, in the manner provided for by the sale of property for the payment of other taxes, such sale shall be made by the city AUditor, or such other officer as may be designated by the Board of Commissioners and a deed a executed by the said City Auditor, or other officer as shall be designated by the Board of Commissioners, and to recite in the deed of such City Auditor or other officer as shall be designated by the board, all legal prerequisites to such sale have been complied with, shall be prima facies evidence of the truth of the facts so recited, which facts shall shall, in all courts of law and equity be presumed to be true without further evidence thereof.

## ARTICLE X.

## RECALL OF ELECTIVE OFFICERS.

SECTION 1. The holders of an elective office may be removed at any time by the qualified voters of the City of Tulsa. The procedure to effect the removal of any incumbent of any elective office shall be as follws: A petition signed by the qualified voters of said city, equal in number to at least 35 per cent of the entire votes cast for the candidates for the off ice of Mayor on the final ballot at the last preceding general municipal election, demanding the election of a successor of the person sought to be removed, shall be filed with the City Auditor provided that the petition sent to the Board of Commissioners shall contain a greneral statement of the grounds for which removal is sought. The signature to the petition need not all be appended to one paper, but each signer shall add to his signature his place of resiments dehce, give the street and number. One of the signers of each such paper shall make oath before and officer competent to administer oaths that the statements herein made are true, and tthat each sighanture to the paper appended is the genuine signature of the person whose name purports to be thereunto subscribed. Within ten flays from the datengf filing such petition the City Auditor shall examine, and from the list of the qualified voters of said city, ascertain whether or not said petiton is signed by the requisaite number of qualified voters, and he shall attach to his said petition his certificate showing the result of said examination if by the A uditor's certificate, the petition is shown to be insufficient, it may be amended within ten days from the date of such certificate. The city Auditor shall within ten days after such amendment, make like examination of the amended petition, and if his certificate shall show the same to be insufficient it shall be returned to the person filing the same, without prejudice, however, to the filing of a new petition to the same effect. It the petition shall be found to be sufficient, the City Auditor shall submit the same to the Board of Commissioners without delay.

- 2. It the petition shall be found to be sufficient, the Board of Comm issioners shall order and fix a date for holding the said election, not less than thirty days, nor more than forty days from the date of the auditors certificate to the Board of Commissioners that a sufficient petition is filed.
- 3. The Boakerd of commissioners shall make or cause to be made publication of notice and all arrangements for holding of such election, and the same shall be conducted, returned and the result thereof declared in all respects as are other city elections, and a majority of all the votes which shall be cast at such election shallbe necessary to elect. In the event no candidate shall receiver majority at the first election, a second election shall be held in accordance withthe provisions of Article III. hereof. The successor of any off icer so removed shall hold office during the unexpired term of his predecessor. Any person sought to be removed may be a candidate
