OIL AND GAS LEASE.

THIS AGREEMENT, Made and entered into this 14 day of November, 1908, by and between James M. Ward, Guardian of Arthur D. Ward, minor, of Claremore , County of Rogers, State of Oklahoma, party of the first part and L. Skransewky, J. W. Johnson and P. S. Johnson, of Claremore, Okla., party of the second part.

WITNESSETH: That the party of the first part, in Consideration of One Dollar, the receipt whereof is hereby acknowledged, and the covenants hereinafter contained on the part of the said party of the second part, does hereby grant, demise and let unto the said lessee, all the oil and gas in and under the following described tract of land, with covenant for the lessee's quiet enjoyment of the term, and that lessor has the right to convey the premises to the said lessee; together with the exclusive right unto the lessee to operate and drill for petroleum and gas, to lay and maintain pipe lines, to erect and maintain telephone and tele-
