That on this 4th, day of May A. D., 1909, the same being one of the regular judicial days of the April term of the District. Court of Tulsa County, Oklahoma, the said Court entered a certain decree, in open Sourt, in Case No. 1059, wherein in said cause, Winifred M. Jordan Guardian of Rachel H. Perryman, Cozetta M. PErryman and Edith M. Perryman, minors was plaintiff, and Ellis A. Yost, A? Hickok, J. T. Taylor, Carl C. Magee, George G. Bayne, J. H. Berry, Ella Horner (nee Perryman), Mary Huffman, Jesse Huffman, Jane A. Price, Henry M. Price, Wilma Price, Hazel Price, Joseph Price, Richard Price, and Henry M. Price, Administrator of the estate of Joseph S. Price, deceased, and george Adams, Frank Price, Charles Price and Harry Price, F. A. Newblock, Sheriff of Tulsa County, State of Oklahoma, in consideration of the premises and the sum of Eighteen Thousand (\$18,000.00) Dollars, to him in hand paid by the said F. A. Gillespie, second party herein, the receipt whereof is hereby acknowledged, has granted, bargained, sold and conveyed, and does hereby and by these present: grant, bargain, sell and convey unto the said F. A. Gillespie, his heirs, executors, administrators and assigns forever, the following described real estate, to-wit:-

The East Half (E_2^+) of the Southeast Quarter (SE_2^+) of the Northwest Quarter (NW/4) and Lot Seven (7) of the West Half (W/2) of the Southwest Quarter (SW/4) of the Northeast Quarter (NE/4) of Section Twelve (12), Township Nineteen (19) North, Range Twelve (12) East, situate in the County of Tulsa and State of Oklahoma. and all right, title, interest and estate in law and equity, of the said Rachel H. Perryman, Cozetta M. Perryman and Edith M. Perryman; together with all and si ngular the tenements hereditaments and appurtenance; thereunto belonging or in anywise appertaining, and all the right, title and interest of all the other parties to said action.
