Fox, Jr., and that it is to the best interest of said Indians, that said land be sold.

The Court further finds that on the 7th day of May, 1909, said William Fox, Tahsalay Corthlony and Luke Fox, executed and delivered a warranty deed to Joseph F. Pautler, folkall of their right, title and interest in said land to Joseph F. Pautler for the Consideration of Two Thousand (\$2000) Dollars; that said sum is a fair and reasonable consideration for the interest of said grantors in said land.

It is therefore considered, ordered and adjudged, by this court, that the said warranty deed made by the said Willam Fox, Luke Fox and Jahsalay Corthlony, conveying the NW.1 of Sec. 14, Township 16 N. R. 13 E. in Tulsa County, Oklahoma, to Joseph F. Pautler, be approved ratified and confirmed in all things, as to the interest of the said William Fox. Tahsalay Corthlony and Luke Fox.

That all of said deeds were made while Mose Jefferson was a minor and that all of the grantees in said deeds were aware of his minority at the time said deeds were taken.

That Mose Jefferson became of age on the 17th, day of April 1909, and on the 20 day of April made a contract with Edward McCoy to sell to said McGoy his interest in lands herein referred to being described as follows:
