STIPULATION INCREASING OIL ROYALTY, EXTENDING TERM OF LEASE, AND CANCELLING REGULATION OF OCTOBER 14, 1907.

WHEREAS THE SECRETARY OF THE INTERIOR has hereforore approved and oil and gas mining lease dated October 17, 1907, entered into by and between Sacherm Oil Company, lessee, and Luther O. Greenfeather, lessor, and whereas the oil royalty is stipulated to be ten per cent of the gross proceeds; and,

WHEREAS, the undersigned the present owner of said lease ____ willing to increase the royalty on oil in said lease to twelve and one half per cent of the gross proceeds on condition that the term of said lease shall be extended to as long as oil or gas is found in paying quantities, and that said lease when extended shall have all the rights, privileges, conditions and terms of the lease form approved and issued April 20, 1908, by the Secretary of the Interior, and that the stipulation subjecting said lease to the regulations of June 11, 1907, as amended October 14, 1907, be revoked and cancelled;

And it has been shown to the Secretary of the Interior that the owner of said lease has notified the owner of the land described in said lease of its willingness to increase said royalty on oil on the terms and conditions herein stated.

NOW, THEREFORE, the owner of said lease on the terms and conditions herein stated does hereby agree that from and after the sate hereof the royalty on oil in said lease shall be twelve and one half per cent of the gross proceeds from the real estate therein described and in consideration thereof the term of said lease shall be, and the same is hereby extended to as long as oil or gas is found in paying quantities, and that all the rights, privileges, conditions and terms of the lease form approved and issued April 20, 1908, by the Secrtary of the Interior, and of this contract, are made a part of said lease first above described, the same as if written therein at length, and all the terms and conditions of said lease as reiginally executed in conflict with the terms and conditions hereof and of said lease form approved April 20, 1908 are rescindend and cancelled. The stipulation subjecting said lease to the regulations of June 11, 1907, as amended October 14, 1907, and to Departement Letter of September 23, 1907 is hereby revoked and rescinded.
