STIPULATION IN CREASING OIL ROYALTY, EXTENDING TERM OF LEASE, AND CANCELING REGULATION OF OCTOBER 14, 1907.

(. To be executed in quadruplicate.)

WHEREAS THE SECRETARY OF THE INTERIOR has heretofore approved and oil and gas mining lease, dated September 2, 1907, entered into by and between Sachem Oil C mpany, lessee, and Nakie Sourjohn, nee Kingfisher, lessor, and wherein the oil royalty is stipula ted to be ten per cent of the gross porceeds; and

WHEREAS, the undersigned, the present owner of said lease----willing to increase the royalty on oil in said lease to twelve and one half per cent of the gross proceeds on condition that the term of said lease be extended to as long as oil or gas is found in paying quantities, and that said lease when extended shall have all the rights, privileges, conditions and terms of the lease form approved and issued April 20, 1908 by the Secretary of the Interior, and that the stipulation subjecting said lease to the regulations of June 11, 1907, as amended October 14, 1907, be revoked and cancelled:

And it has been shown to the Secretary of the Interior that the owner of said lease has notified the owner of the land described in said lease of its willingness to increase said royalty on oil on the terms and conditions herein stated:

NOW, THEREFORE, the owner of said lease on the terms and conditions herein stipulated does hereby agree that from and after the date hereof the royalty on oil in said lease shall be twelve and one half per cent of the gross proceeds from the real estate therein doccribed, and in consideration thereof the term of said lease is shall be, and the same is hereby extend to as long as oil or gas is found in paying quantities, and that all the rights privileges, conditions and terms of the lease form approved and issued April 20, 1908, by the Secretary of the Interior, and of this contract, are made a part of said lease first above described, the same as if written therein at length, and all the terms and conditions of said lease as originally executed in conflict with the terms and conditions hereof, and of said lease form approved April 20, 1909, are rescinded and cancelled. The stipulation subjecting said lease to the regulations of June 11, 1907, as amended October 14, 1907, and to Deaprtment letter of September 26, 1907, is hereby revoked and rescinded.
