WHEREAS Alvin T. Hodge, and Allottee of the Creek Nation, has made application for the removal of restrictions from the following described lands, to-wit:

The Southeast Quarter (SE/4) of the Northwest Quarter (NW/4) of Section Six (6), Township Nineteen (19) North, and Range Thirteen (13) East of the Indian Base and Meridian, containing 40 acres.

NOW, THEREFORE, I, Under the authority vested in me by the Act of Congress approved May 27, 1908 (Public No. 140), and the regulations prescribed thereunder, hereby remove the restrictions from said above described land without conditions concerning terms of sale and disposal of the proceeds; said removal of restrictions to be effective thirty days from date hereof.

A G R E E M E N T.

THIS AGREEMENT, Made and entered into on this 24th, day of April A. D. 1909, by and between Charles W. Grimes, of Tulsa, Oklahoma, party of the first part, and O. M. Lancaster, P. M. Kerr, Joseph Cooper and W. B. Grimes, parties of the second part,

WITNESSETH: That, Whereas, all the parties hereto did purchase from Alvin T. Hodge and Mary J. Hodge, his wife, on the 11th, day of April A. D. 1909, the following described tract of land, to-wit:

All the Southeast Quarter ( $\frac{1}{4}$ ) of the Northwest Quarter ( $\frac{1}{4}$ ) of Section Six (6), Township Nineteen (19) North, Range Thirteen (13) East ( except the following described portions thereof to-wit: The North Sixty (60) feet heretofore dedicated as a public highway by grantors; also a plat of ground beginning Sixty (60) feet South of the Northwest Corner of the Southeast Quarter ( $\frac{1}{4}$ ) of the Northwest Quarter ( $\frac{1}{4}$ ) of said Section Six (6), Township Nineteen (19) North Range Thirteen (13) East; Thence East Three Hundred and Sixty (360) feet; Thence South Three Hundred and Thirty (330) feet; Thence West Three Hundred and Sixty (360) feet; Thence North Three Hundred and Thirty (330) feet to the place of beginning; said tract Three Hundred and Thirty (330) feet by Three Hundred and Sixty (360) feet being heretofore conveyed to the Board
