The West Half of the North East Quarter of Section 26, Township 22, Range 13 in Tulsa County Oklahoma, containing eighty acres, and it further appearing that the said Lula Fields is the only person interested in said lands; and it further appearing that it is for the best interest of the said minor to have said land developed for oil and gas purposes, in order that funds may be ^{secured} ~~obtained~~ for the proper education, maintenance and support of said minor; and it further appearing that the estate of said minor is not financially able to develop said lands for oil and gas purposes; and it further appearing that under an order of this court heretofore made and issued, said J. J. Fields has executed to W. E. Halsell, of Vinita, an oil and gas mining lease on the above described lands of said minor; and it further appearing that said W. E.
