WITNESSETH: That said party of the first part, formand in consideration of the sum of Ten (\$10) Dalars and other valuable considerations, the receipt whereof is hereby acknowledged does by these presents grant, bargain, sell and convey unto said party of the second part, its successors and assigns, all of the following described real estate, situated in the County of Tulsa, and State of Oklahoma, to-wit:

Lot Seven (7) in Block 30, and that part of Lot Six (6) in Block 30, which Joins

Lot Seven and that a frontage of 50 feet on Cheyenne Rvenue, and depth of 140 feet to an alley, and a uniform width of 50 feet in the City of Tulsa, Oklahoma, as shown by the recorded plat thereof.

TO HAVE AND TO HOLD THE SAME, together with all and singular the tenements, hereditaments and appurtenances thereunto belonging or in anywise appertaining forever.

And the said Board of Church Extension of the United Presbyterian Church of North America, its successors and assigns, does hereby covenant, promise and agree to and with the said party of the second part, that at the delivery of these presents it is lawfully seized in its own right of an absolute and indefeasible extate of inheritance, in fee simple, of and in all and singular the above granted addescribed premises, with the appurtenances; that the same are free, clear, discharged and unincumbered of and form all former and other grants, titles, charges, estates, judgements, taxes, assessments and encumbrances, of what nature or kind soever; and that it will warrant and forever defend the same unto said party of the second part its successors and assigns, amainst said party of the firstpart, its successors and assigns, and all and every person or persons whomsoever, lawfully claiming or to claim the same.
