An consideration of the premises, the said part of the second part covenant, and agree: 1st—To deliver to the credit of the part of the first part, and heirs, administrators, executors and assigns, free of cest in the pipe line to which part of all
oil produced and saved from the leased premises: And 2nd—To pay fifth Dollars each three months in advance for the gas, from each and every gas well drilled on said premises, the gas from which is marketed and used off the remises, while the gas from said well is so marketed and used.  Second part of covenant and agree to locate all wells so as to interfere as little as possible with the cultivated portion of the farm. And further, to complete a well on said
premises within Intellect mouths. from the date hereof, or pay at the rate of threel and 13/100. Dollars, quarterly in advance, for each additional three mouths such completion is delayed from the time above mentioned for the completion of such well until a well is completed; and it is agreed that the completion of such well shall be and operate as a full liquidation of all rental under this provisions during the remainder of the term of this lease. Such payments may be made direct to the lessor
First part Ato have gas free for fuel and light in the dwelling on said premises by making own connections to any well thereon.  It is agreen that the second part At shall have the privilege of using sufficient water, oil and gas from said premises to run all machinery necessary for drilling and operating thereon, and at any time to remove all machinery and fixtures placed on said premises; and further, upon the payment of
at any time, by the part 45 of second part. heirs, administrators, executors, successors and assigns, to the part 45 of the first part, heirs, executors,
administrators and assigns, said part of the second part, heirs, executors, administrators, successors and assigns, shall have the right to surrender this lease for cancellation, after which all payments and liabilities thereafter to accrue under and by virtue of its terms shall cease and determine, and this lease become absolutely null and void.
