AGREEMENT, Made and entered into the 29th day of September, A. D. 1910, by and between
R.B. Butts of Muskogee
 Oklahoma, party of the first part, and A.W. Shults
 of his

WITNESSETH, That the said party of the first part, for and in consideration of the sum of one Dollar to him in hand well and truly paid by the said party of the second part, the receipt of which is hereby acknowledged, and of the covenants and agreements hereinafter contained on the part of the said party of the second part, to be paid, kept and performed, has he granted and conveyed, and by these presents do he grant and convey unto the said party of the second party his successors or assigns, for the sole and only purpose of mining and operating for oil and gas, and of laying pipe lines, and of building tanks, stations and structures thereon to take care of the said products, ALL that certain tract of land, situate in Seesaw County, Oklahoma, to-wit:

Southwest of northeast quarter and northwest quarter of South East quarter of Section 1 Nineteen
(19) Township Twenty-two (22) North and Range Thirteen (13) East.

Containing 80 acres, more or less, reserving, however, therefrom 150 feet around the buildings on which no well shall be drilled by either party except by mutual consent.

It is agreed that this grant shall remain in force for the term of ten years from this date, and as long thereafter as oil or gas, or either of them, is produced therefrom by the party of the second party his successors or assigns.

IN CONSIDERATION OF THE PREMISES The said party of the second part covenants and agrees: 1st-To deliver to the credit of the first party his heirs or assigns, free of cost, in the pipe line to which it may connect its wells, or in tanks at the wells, or pay the market price therefor in cash, the equal 18

part of all oil produced and saved from these premises; and 2nd-To pay 18.150 Dollars per year for the gas from each and every gas well drilled on said premises; the product from which is marketed and used off the premises, said payments to be made on each well within sixty days after commencing to use the gas therefrom, as aforesaid, and to be paid yearly thereafter, while the gas from said well is so used.

Second party covenants and agrees to located all wells so as to interfere as little as possible with the cultivated portions of the premises. And further, to complete a well on said premises within from the date hereof, or pay at the rate of from Dollars, quarterly, in advance, for each additional three months such completion is delayed from the time above mentioned for the completion of such well until a well is completed; and it is agreed that the completion of such well shall be and operate as a full liquidation of all rental under this provision during the remainder of the term of this grant.

The party of the second part further agrees that in case no well is drilled for oil or gas within one year from the date hereof, all rights and obligations accrued under this grant and demise shall cease upon three months notice in writing being served by the party of the first part upon the party of the second part who shall elect from year to year to continue this grant and demise for as long as all portions of the premises by paying in advance an annual rental of \$1.00 per acre for as of said land or such portion thereof, and the party of the second part may designate which a well is drilled, provided that upon the completion of said well the above provided for rentals shall cover such payments shall be made to R.B. Butts or deposited to his credit in the Muskogee National Bank of Muskogee, Oklahoma.

IT IS AGREED That the second party is to have the privilege of using sufficient water from the premises to run all necessary machinery and at any time to remove all machinery and fixtures placed on said premises; and, further, upon the payment of one Dollar, at any time after giving three months' notice by the party of the second part, its successors or assigns, to the party of the first part his heirs or assigns, said party of the second part, its successors or assigns, shall have the right to surrender this grant for cancellation, after which all payments and liabilities thereafter to accrue under and by virtue of its terms shall cease and determine, and this grant become absolutely null and void.
