the receipt of which is hereby acknowledged, do they by these presents grant, bargain, sell and convey unto the said part 2d of the second part,
their heirs and assigns, all of the following-described real estate, situated in the County of Tulsa
and State of Oklahoma, to-wit:

Lot two (2) Block fifteen (15) Located in the Original Townsite
of Tulsa Okla. (Land, Tex) and according to the official plat
and Government Survey of said City of Tulsa Okla.

To have and to hold the same, together with all and singular the tenements, hereditaments and appurtenances thereunto belonging or in
anywise appertaining forever.
