MORTGAGE OF REAL ESTATE—BANK DODGORTH BROS. CO., LEAVENWORTH, KAN. No. 19788.

THIS INDENTURE, Made this 14th day of October, A. D. 1929, between Lee M. Lewis and Ida M. Lewis, his wife, of Tulsa County, in the State of Oklahoma, of the first part, and M. J. Hall and J. P. Lewis, of Tulsa County, in the State of Oklahoma, of the second part:

WITNESSETH, That said parties of the first part, in consideration of Eighteen Hundred Dollars (\$1,800.00), the receipt of which is hereby acknowledged, do by these presents, grant, bargain, sell and convey unto said parties of the second part, their heirs and assigns, the following-described Real Estate, situated in Tulsa County, and State of Oklahoma, to-wit:

The northerly fifty (50) feet of the easterly end half of lot two (2) and three (3) in Block 11, Lot 11, according to the government plat and survey thereof, subject to a mortgage for \$1,000.00 to J. J. Daly.

TO HAVE AND TO HOLD THE SAME unto the said parties of the second part, their heirs and assigns, together with all and singular the tenements, hereditaments and appurtenances thereunto belonging, or in anywise appertaining, forever.

PROVIDED, ALWAYS, And these presents are upon this express condition, that whereas said Lee M. Lewis and Ida M. Lewis have this day executed and delivered their certain promissory note, in writing to said parties of the second part, described as follows: Dated at Tulsa, Oklahoma, October 15, 1929, due four months after date, payable to the said M. J. Hall and J. P. Lewis, or order, and calling for \$1,800.00, with interest thereon from date at rate of 10% per annum, for value received, and signed by said Lee M. Lewis and Ida M. Lewis.

Now, if said parties of the first part shall pay or cause to be paid to said parties of the second part, their heirs or assigns, said sum of money in the above-described note mentioned, together with the interest thereon, according to the terms and tenor of the same, then this mortgage shall be wholly discharged and void; and otherwise shall remain in full force and effect. But if said sum or sums of money or any part thereof, or any interest thereon, is not paid when the same is due, and if the taxes and assessments of every nature which are or may be assessed and levied against said premises or any part thereof are not paid when the same are by law made due and payable, the whole of said sum or sums, and interest thereon, shall then become due and payable, and said parties of the second part shall be entitled to the possession of said premises. And the said parties of the first part for said consideration do hereby expressly waive an appraisal of said real estate and all benefit of the homestead exemption and stay laws of the State of Oklahoma.
