THIS INDENTURE, Made this 12th day of October, A. D. 1927, between Christ M. Guirel and Lillie M. Guirel, his wife of Tulsa County, in the State of Oklahoma, of the first part, and The Bank of Bixby of Bixby, Tulsa County, in the State of Oklahoma, of the second part:

WITNESSETH, That said part.....of the first part, in consideration of

the receipt of which is hereby acknowledged, do hereby these presents, grant, bargain, sell and convey unto said party of the second part the heirs and assigns, the following-described Real Estate, situated in Bixby, Indian County, and State of Oklahoma, to-wit: all of lot ten (10) in Block twenty two (22) in the original townsite of Bixby, Okla. according to the old Court survey and plat by said town. Dollars (\$ 83.90), DOLLARS

TO HAVE AND TO HOLD THE SAME unto the said party of the second part, etc heirs and assigns, together with all and singular the tenements, hereditaments and appurtenances thereunto belonging, or in anywise appertaining, forever.

PROVIDED, ALWAYS, And these presents are upon this express condition, that whereas said Charles M. Howard and Lillie M. Cruise
have this day executed and delivered to him, certain promissory note, in writing to said party of the second part, described as follows:

On April 22nd 1914 without grace after date, for value received, we as principal, promise to pay to the order of the Bank of Blythe, Blythe, Oklahoma, eighty three & 2/3 Dollars. In lawful money of the United States of America, or of equal to the face value of a check, with interest at two per cent, per annum, from maturity; interest to become as principal when due and bear the same rate of interest. The maker and endorser of this note, hereby severally and jointly, presentment for payment, notice of non-payment, protest, and notice of protest, and consent that time of payment may be extended without notice thereof, affirmed and all exemptions removed. If suit be instituted on a note that judgment be rendered for ten per cent, additional, as attorney's fees, and we hereby give full authority to said The Bank of Blythe, or its assigns, to use any collateral security assigned or attached to public or private sale, without notice, before or after maturity and sum of \$83.66

Now, if said part 1st of the first part shall pay or cause to be paid to said part 2d of the second part itself heirs or assigns, said sum of Five, 00/100 money in the above-described note...mentioned, together with the interest thereon, according to the terms and tenor of the same, then this mortgage shall be wholly discharged and void; and otherwise shall remain in full force and effect. But if said sum or sums of money or any part thereof, or any interest thereon, is not paid when the same is due, and if the taxes and assessments of every nature which are or may be assessed and levied against said premises or any part thereof are not paid when the same are by law made due and payable, the whole of said sum or sums, and interest thereon, shall then become due and payable, and said part 2d of the second part shall be entitled to the possession of said premises. And the said part 1st of the first part for said consideration do...hereby expressly waive an appraisement of said real estate and all benefit of the homestead exemption and stay laws of the State of Oklahoma.
