FOR THE CONSIDERATION OF One Hundred DOLLARS, the receipt of which is hereby acknowledged, William D. Samble & Alice Samble

and his wife, of Tulsa County, State of Oklahoma, first party, hereby mortgage and convey to Sam Brothers of Oklahoma

City, Oklahoma Second part, the following real estate situated in Tulsa County, State of Oklahoma, described as follows, to-wit:

The Northeast Quarter of Section Twenty-five (25) Township
thirteen (13) North of Range thirteen (13) East of
the following described tract: Beginning at the Northeast corner
of said Section and running West 161.90 feet; thence running
South 2380.1 feet to the north line of right of way of Missouri,
Kansas & Texas Railway; thence running in a southeasterly
direction along the north line of said right of way to point of intersection with south
line of the North East Quarter of said Section; thence East along the last
mentioned line to the Southeast corner of said quarter section thence North to place
beginning, subject to a mortgage of \$1400.00 to Sam Brothers Company, Tulsa, Okla.,
together with all rents and profits therefrom and all improvements, appurtenances, now or hereafter in anywise belonging thereto; and the said

first party hereby warrants the title thereto against all persons whomsoever. This mortgage is given as security for the performance of the covenants herein, and the payment of said second party, successors or assigns the principal sum of

with interest thereon at the rate of 10 per cent per annum until maturity, and at Ten per cent per annum after maturity, said interest to be paid _____ annually, principal and interest payable at the office of Sam Brothers according to the conditions of the one promissory note _____ of the said William D. Samble & Alice Samble, his wife

for said amount made and delivered unto said second party, being of even date herewith, and due as above stated. The said first party shall not commit or suffer waste, shall pay all taxes and assessments upon said property, to whomsoever assessed, including

personal taxes, before delinquent; shall keep the buildings thereon insured to the satisfaction of said second party for at least _____ Dollars, delivering all policies and renewal receipts to said second party; and upon the satisfaction of this mortgage will accept from the mortgagee a duly executed release of the same, have it recorded and pay for the recording.

A failure to comply with any of the agreements herein shall cause the whole debt secured hereby to at once become due and collectible, if said second party or assigns so elect, and no demand for fulfillment of conditions broken, nor notice of election to consider the debt due shall be necessary previous to commencement of suit to collect the debt hereby secured, or any part thereof, or to foreclose this mortgage. And in case of default, said second party may take immediate possession of said premises; and if suit is commenced to foreclose this mortgage, the said second party shall be entitled to have a receiver appointed to take charge of said real estate during such litigation and the period of redemption from sale thereunder, accounting to the mortgagor for the net income, only, applying the same in payment of any part of the debt secured hereby remaining unpaid, and upon short sale said first party waives the platting of homestead and agrees that said land may be sold in one body. All money paid by second party for insurance, taxes or assessments upon said property, or for taxes which may hereafter be levied upon this mortgage, and expense of continuation of abstract, and all expenses and attorneys fees incurred by said second party and assigns by reason of litigation with third parties to protect the lien of this mortgage, shall be recoverable against said first party, with penalties upon tax sales, and shall bear interest at the rate of Ten per cent per annum, payable annually, and be secured by this mortgage as a part of the mortgage debt.

And in case of foreclosure hereof, said first parties hereby agree to pay the sum of _____ Dollars, attorney's fees in such foreclosure suit, to be secured by this mortgage, and for the consideration above hereby expressly waive the appraisalment of said real estate and all benefits of the homestead and stay laws of the state.
