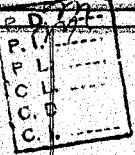

Warranty Deed

WITH RELINQUISHMENT OF DOWER.

Know All Men By These Presents:

That we S. K. Williams and Bessie L. Williams
his wife, for and in consideration of the sum of Twelve 50 DOLLARS,
to us paid by Cecil Pender

do hereby ^{grant} bargain, grant, sell and convey unto the said Cecil Pender
and unto his heirs and assigns forever, the following lands lying in the
Western District of the Indian Territory, to-wit:

N.E. 1/4 of the N.W. 1/4 and the west half (shown on the U.S. Survey as lots 1 & 2) of the N.W. 1/4
of Sec. 31, T. 12 N. and Range 14 E, Creek Nation Western District of the
Indian Territory, to-wit: Lot 27, No Twenty-seven Block 3 No. Three
in Valley, I. T.

To have and to hold the same unto the said Cecil Pender and unto his heirs
and assigns forever, with all appurtenances thereunto belonging.

And hereby covenant ~~with and~~ And we hereby covenant with said Cecil Pender that we
will forever warrant and defend the title ^{to the} of said lands against all claims whatever.

And I, Bessie L. Williams wife of the said S. K. Williams
for and in consideration of the said sum of money, do hereby release and relinquish unto the said Cecil Pender
all my rights of dower and homestead in and to the said lands.
