Know All Men By These Presents:

That we S. K. Williams and Bessie L. Williams

do hereby ~~grant~~ ^{convey}, grant, sell and convey unto the said Hanna R. Dickinson
 and unto her heirs and assigns forever, the following lands lying in the NW 1/4 of the NW 1/4 and the West half Section on the 10.
Survey of lots 17 & 21 of the NW 1/4 of Sec 31, T19N and Range 17E, Creek Nation
 Western District of the Indian Territory, to-wit:

Lot 12 No. Twelve Block 15 No. fifteen
" 6 " Six " 8 " eight
in Valley, D.T.

To have and to hold the same unto the said Hannah R. Dickinson and unto her heirs
 and assigns forever, with all appurtenances thereunto belonging.

And hereby covenant we with said Hannah R. Dickinson that we
 will forever warrant and defend the title to the said lands against all claims whatever.

And I, Bessie L. Williams wife of the said S. K. Williams
 for and in consideration of the said sum of money, do hereby release and relinquish unto the said Hannah R. Dickinson
 all my rights of dower and homestead in and to the said lands.
