Warranty Deed

WITH RELINQUISHMENT OF DOWER.

Know All Men By Those Presents:

That I, J. M. Gillette, a single man,
his wife, for and in consideration of the sum of Three Hundred and Fifty no/100 DOLLARS,
to me in hand paid by J. M. Hall, the receipt of which is hereby acknowledged,

^{do hereby bargain,} do hereby bargain, grant, sell and convey unto the said J. M. Hall,
and unto his heirs and assigns forever, the following lands lying in the Cherokee Nation,

Western District of the Indian Territory, to-wit:

All of an undivided one fourth interest, in and to the West half of the Northwest quarter of the Southeast quarter and the Southeast quarter of the Northwest quarter of the Southeast quarter of Section Eight (8) Township Twenty (20) North Range Thirteen (13) East, containing 30 acres more or less.

To have and to hold the same unto the said J. M. Hall, and unto his heirs and assigns forever, with all appurtenances thereunto belonging.

And hereby covenant with said J. M. Hall, that I will forever warrant and defend the title of said lands against all claims whatever.

And I, wife of the said J. M. Gillette, do hereby release and relinquish unto the said J. M. Gillette, for and in consideration of the said sum of money, do hereby release and relinquish unto the said J. M. Gillette, all my rights of dower and homestead in and to the said lands.
