# Warranty Deed

WITH RELINQUISHMENT OF DOWER.

## Know All Men By These Presents:

That we Low R. Stansbury and Myrtle C. Stansbury  
his wife, for and in consideration of the sum of (1600<sup>00</sup>) Six Hundred DOLLARS,

do hereby <sup>inquit</sup> bargain, grant, sell and convey unto the said John N. May  
and unto His heirs and assigns forever, the following lands lying in the Creek Nation  
Western District of the Indian Territory, to-wit:

A One Half interest in Lots 1 and 2 Block 3 in Stansbury Addition to Tulsa, I. T.

To have and to hold the same unto the said John N. May and unto His heirs  
and assigns forever, with all appurtenances thereunto belonging.

And hereby covenant with said John N. May that we  
will forever warrant and defend the title of said lands against all claims whatever.

And I, Myrtle C. Stansbury wife of the said Low R. Stansbury  
for and in consideration of the said sum of money, do hereby release and relinquish unto the said John N. May  
all my rights of dower and homestead in and to the said lands.
