WITH RELINQUISHMENT OF DOWER.

Know All Men By These Presents:

That we Maurice W. Le Vinna and Etta M. Le Vinna
his wife, for and in consideration of the sum of Eight Hundred & 80.00 DOLLARS,
In hand paid by J. F. Koons, the receipt of which is hereby acknowledged and confessed.

do hereby ~~grant~~ ^{relinquish} grant, sell and convey unto the said J. F. Koons
and unto his heirs and assigns forever, the following lands lying in the Brady Heights Addition to Tulsa, D.T.
Western District of the Indian Territory, to-wit:

Lots Four (4) and Five (5) in Block Two (2) in Brady Heights Addition to Tulsa,
D.T. according to the recorded plat thereof.

To have and to hold the same unto the said J. F. Koons and unto his heirs
and assigns forever, with all appurtenances thereunto belonging.

And hereby covenant S. with said J. F. Koons that they
will forever warrant and defend the title of said lands against all claims whatever.

And I, Etta M. Le Vinna wife of the said Maurice W. Le Vinna
for and in consideration of the said sum of money, do hereby release and relinquish unto the said J. F. Koons
all my rights of dower and homestead in and to the said lands.
