WITH RELINQUISHMENT OF DOWER.

Know All Men By These Presents:

That we, S. K. Williams and Bessie L. Williams
his wife, for and in consideration of the sum of Twelve 50/100 DOLLARS,
to us paid by C. S. Stewart

do hereby ~~buy~~ ^{buy} grant, sell and convey unto the said C. S. Stewart
and unto his heirs and assigns forever, the following lands lying in the NW 1/4 of the NW 1/4 and the West half Section on the
U. S. Survey as lots 172 of the NW 1/4 of Sec. 31, T19N and Range 14E, Creek Nation
Western District of the Indian Territory, to-wit:

Lot 5 No. five Block 22 No. twenty five in Valley P. I.

To have and to hold the same unto the said C. S. Stewart and unto his heirs
and assigns forever, with all appurtenances thereunto belonging.

And hereby covenant with said C. S. Stewart that we
will forever warrant and defend the title ^{to the} of said lands against all claims whatever.

And I, Bessie L. Williams wife of the said S. K. Williams
for and in consideration of the said sum of money, do hereby release and relinquish unto the said C. S. Stewart
all my rights of dower and homestead in and to the said lands.
