WITH RELINQUISHMENT OF DOWER.

## Know All Men By These Presents:

That we S. K. Williams and Bessie L. Williams  
his wife, for and in consideration of the sum of Twelve 00/100 DOLLARS,

to be paid by E. K. Brinn

do hereby ~~grant~~ <sup>release</sup> grant, sell and convey unto the said E. K. Brinn

and unto his heirs and assigns forever, the following lands lying in the N 1/4 of Sec 31, T 19 N, and Range 14 E, Creek Nation,  
Western District of the Indian Territory, to-wit:

Lot 1 No Eight Block 4 No Town in Valley D. I.

To have and to hold the same unto the said E. K. Brinn and unto his heirs  
and assigns forever, with all appurtenances thereunto belonging.

And hereby covenant with said E. K. Brinn that we  
will forever warrant and defend the title <sup>to the</sup> of said lands against all claims whatever.

And I, Bessie L. Williams wife of the said S. K. Williams  
for and in consideration of the said sum of money, do hereby release and relinquish unto the said E. K. Brinn  
all my rights of dower and homestead in and to the said lands.
