# Warranty Deed

WITH RELINQUISHMENT OF DOWER.

## Know All Men By These Presents:

That we, S. K. Williams and Bessie L. Williams  
his wife, for and in consideration of the sum of Twelve 12 DOLLARS,  
to be paid by Katie B. Winters

do hereby ~~grant~~ <sup>renew</sup> grant, sell and convey unto the said Katie B. Winters  
and unto her heirs and assigns forever, the following lands lying in the NW 1/4 of the NW 1/4 and the West half shown on the U.S. survey  
acres 142 of the NW 1/4 of Sec. 21, T. 19 N. and Range 14 E, Creek Nation,  
Western District of the Indian Territory, to-wit:

Lot 17, No. sixteen Block 12 No. Twelve in Valley S.T.

To have and to hold the same unto the said Katie B. Winters and unto her heirs  
and assigns forever, with all appurtenances thereunto belonging.

And we hereby covenant with said Katie B. Winters that we  
will forever warrant and defend the title <sup>to the</sup> of said lands against all claims whatever.

And I, Bessie L. Williams wife of the said S. K. Williams  
for and in consideration of the said sum of money, do hereby release and relinquish unto the said Katie B. Winters  
all my rights of dower and homestead in and to the said lands.
