Warranty Deed

WITH RELINQUISHMENT OF DOWER.

Know All Men By These Presents:

That we W. D. Weaver and Bettie Weaver, his wife, for and in consideration of the sum of six Hundred and one/100 DOLLARS, to us in hand paid the receipt of which is hereby acknowledged,

do hereby ^{voucage} grant, sell and convey unto the said George Campbell and unto his heirs and assigns forever, the following lands lying in the Town of Tulsa,

Western District of the Indian Territory, to-wit:

A Plat of ground 40 x 140 ft off of the north end of Lot One and Seven Block #127 and more particularly described as follows: Beginning at a point on the northeasterly corner of said lot one; thence running in a northwesterly direction and parallel to Houston Ave., a distance of forty feet; thence in a westerly direction and parallel to Third Street a distance of 140 feet; thence in a southwesterly direction and parallel to Houston Ave., a distance of 40 feet; thence in a easterly direction parallel with the alley a distance of 140 feet to point of beginning, including one half interest in and to well and sheds, all in the Town of Tulsa, Indian Territory, according to the Governmental survey thereof. George Campbell and unto his heirs and assigns forever, with all appurtenances thereunto belonging.

And hereby covenant with said George Campbell that we will forever warrant and defend the title of said lands against all claims whatever.

And I, Bettie Weaver, wife of the said W. D. Weaver, for and in consideration of the said sum of money, do hereby release and relinquish unto the said George Campbell all my rights of dower and homestead in and to the said lands.
