THIS ENDURABLE OIL AND GAS LEASE is made and entered into in quadruplicate on this 3rd day of October A.D. 1905 by and between William H. Blakmore, Guardian of Henry Starkey a Minor born January 30th 1901 of Okawasso, Indian Territory party of the first part, and Colvin Oil and Gas Company of Bartlesville Indian Territory, a corporation duly organized and existing under the laws of the Indian Territory, and authorized to carry on business in the Indian Territory by compliance with the law in force therein, party of the second part, it under and in pursuance of the revisions of Section 32 of the Act of Congress approved July 1, 1902, and the regulations prescribed by the Secretary of the Interior thereunder.

RECORD: That the party of the first part, for and in consideration of the royalties, covenants stipulations and conditions herein after contained and hereby agreed to be fully observed and performed by the party of the second part, its successors and assigns, does hereby demise, grants, and let unto the party of the second part, the minerals and oil for the term of fifteen years from the date hereof, all of the oil rights and natural gas in or
