The Court further finds that on the 18th day of October, 1909, the Court signed an order fixing Thurdsday the 28th day of October 1909, at the hour of 10 o'clock A.M. as the time on which a hearing on the return of sale herein described would be had, and notices of such hearing in due and legal form was posted in three of the most public places in therefore county, State of Oklahoma, at least 10 days before the time set for said hearing, that proof of posting has been duly made, and that on the 28th day of October, 1909, the hearing on said return was duly made.
