as lessee, the said W.R. Wright do hereby this day and by these presents demise and let to the said R.W. Wright, the said lessee, his neirs and assigns, for agricultural purposes, for the term of five years from January 1st, 1908, the following lands of said Lizzie McIntosh, described as follows:

The northeast quarter of section sixteen in Township 19 North and Range 14 East, of Indian Base and Meridian, in State of Oklahoma, and containing 160 acres as allotted to said Lizzie McIntosh; also the lands of one said Bennie KcIntosh, described as follows:

The southeast quarter of the section nine in Township 19 North and Range 14 East of the Indian Base and Meridian in State of Oklahoma, and containing 160 acres, as allotted to said Bennie McIntosh;

It is hereby understood and agreed that said lessee will pay said Jim Caesar as said Guardian the sum of one hundred and twenty five dollars per annum during the term of this tenancy, as rental to each of said minors, said rental to be paid on 1st day of March of each year during the life of this lease.

The said lessee hereby further agrees to dig one well on each tract of said land; to repair the zences on said premises; to plant and cultivate 1/8 acre of small fruits on each tract of said lands; and to break out and put in cultivation from time to time all of the tillable land on said premises save and except that part of each tract of said lands that is needed for pasture and grass purposes.
