WARRANTY DEED.

THIS INDENTURE, made this 3 day of Dec. 1909 between Mary E. McElhaneey and W.B. McElhaneey of Muskogee, County, in the state of Okla. of the first part and W.S. Woodson, O.F. Woodson and J.L. Hutcherson of Tulsa, County in the st. State of Okla. of the second part,

WITNESSETH, that said parties of the first part, for and in consideration of the sum of One Thousand four Hundred and No/100 Dollars to us in hand paid by the said parties of the second part, the receipt whereof is hereby acknowledged, does by these presents grant, bargain, remise, release, sell, convey and confirm unto the said party of the second part their heirs and assigns forever, all of our right, title and interest in and to the following described real estate, lying and situated in the county of Tulsa and State of Oklahoma, to-wit:

1 1/2 of S 1/4 of Sec. 28, Twp. 21 Range 13 E. Less one acre in the extreme S.E. Corner set aside for cemetery containing 79 acres more or less.

TO HAVE AND TO HOLD THE SAME, together with all and singular the tenements, hereditaments and appurtenances thereto belonging, or in any wise appertaining, unto the said part of the second part their heirs and assigns forever. And the said part-- of the first part, for ourselves and our heirs do covenant, promise and agree to and with said parties of the second part, their heirs, executors, administrators and assigns, that we will warrant and
